Vendor set-up will begin at 9:30am; all cars must be removed from the festival area by 10:45. Vendors are responsible for providing their own tables, tents, chairs, etc. We highly recommend bringing a tent as this is a RAIN OR SHINE event. NO ELECTRIC WILL BE PROVIDED. Main Street New Egypt (MSNE) reserves the right to limit the number or type of vendors participating, and will be solely responsible for determining vendor locations. Vendors are required to remain set up for the duration of the event. (Note: MSNE reserves the right to request insurance from vendors as deemed necessary.)

**FOOD VENDORS** are by invitation only, and must be compliant with Ocean County health permits and license requirements. A Certificate of Insurance in the amount of \$1,000,000 is REQUIRED. It must specifically name Plumsted Township AND Main Street New Egypt as "Additional Insured's" and must include the date, name and location of the event. **Insurance and health certificates must accompany application.**
